

**HIGHLAND COUNCIL
THE HIGHLAND COUNCIL (GRANTOWN ON SPEY AND KINGUSSIE
SCHOOLS) (PART TIME 20MPH SPEED LIMIT) ORDER 2005**

The Highland Council in exercise of the powers conferred on them by Section 84 of the Road Traffic Regulation Act 1984 and of all powers enabling them in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act hereby make the following order :-

GENERAL

1. This Order may be cited as "The Highland Council (Grantown on Spey and Kingussie schools) (Part Time 20mph Speed Limit) Order 2005" and shall come into effect on 16 August 2005.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. All provisions contained in any Order enactment or others insofar as the same are inconsistent with the provisions of this Order and the true intent and meaning hereof shall cease to have effect and are hereby revoked.

ROADS (20 MPH)

4. No person shall drive or cause to be driven any vehicle on the lengths of road specified in the Schedule annexed and signed as relative to this Order at a speed in excess of 20 miles per hour at a time when the amber lights on any traffic sign or signs warning of this restriction are flashing.
5. It shall be sufficient for the purposes of this Order that said warning sign or signs be erected on only one side of the road.

SCHEDULE TO THE HIGHLAND COUNCIL (GRANTOWN ON SPEY AND KINGUSSIE SCHOOLS) (PART TIME 20MPH SPEED LIMIT) ORDER 2005

B970 Station Road/Ruthven Road, Kingussie

From the junction of Station Road with the A86 Newtonmore Road, southwards to a point 47 metres or thereby south of the centre line on Market Lane a distance of 318 metres or thereby.

C47 South Street, Grantown.

From a point 102 metres or thereby north-east of the north-east extended kerb-line on the road leading to Strathspey Lodges, south-westwards for a distance of 175 metres or thereby.
