
GENERAL

1. This Order may be cited as "The Highland Council (Various Schools in Lochaber No. 2) (Part Time 20mph Speed Limit) Order 2005" and shall come into effect on 23 January, 2006
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. All provisions contained in any Order enactment or others insofar as the same are inconsistent with the provisions of this Order and the true intent and meaning hereof shall cease to have effect and are hereby revoked.

ROADS (20 MPH)

4. No person shall drive or cause to be driven any vehicle on the lengths of road specified in the Schedule annexed and signed as relative to this Order at a speed in excess of 20 miles per hour at a time when the amber lights on any traffic sign or signs warning of this restriction are flashing.
5. It shall be sufficient for the purposes of this Order that said warning sign or signs be erected on only one side of the road.

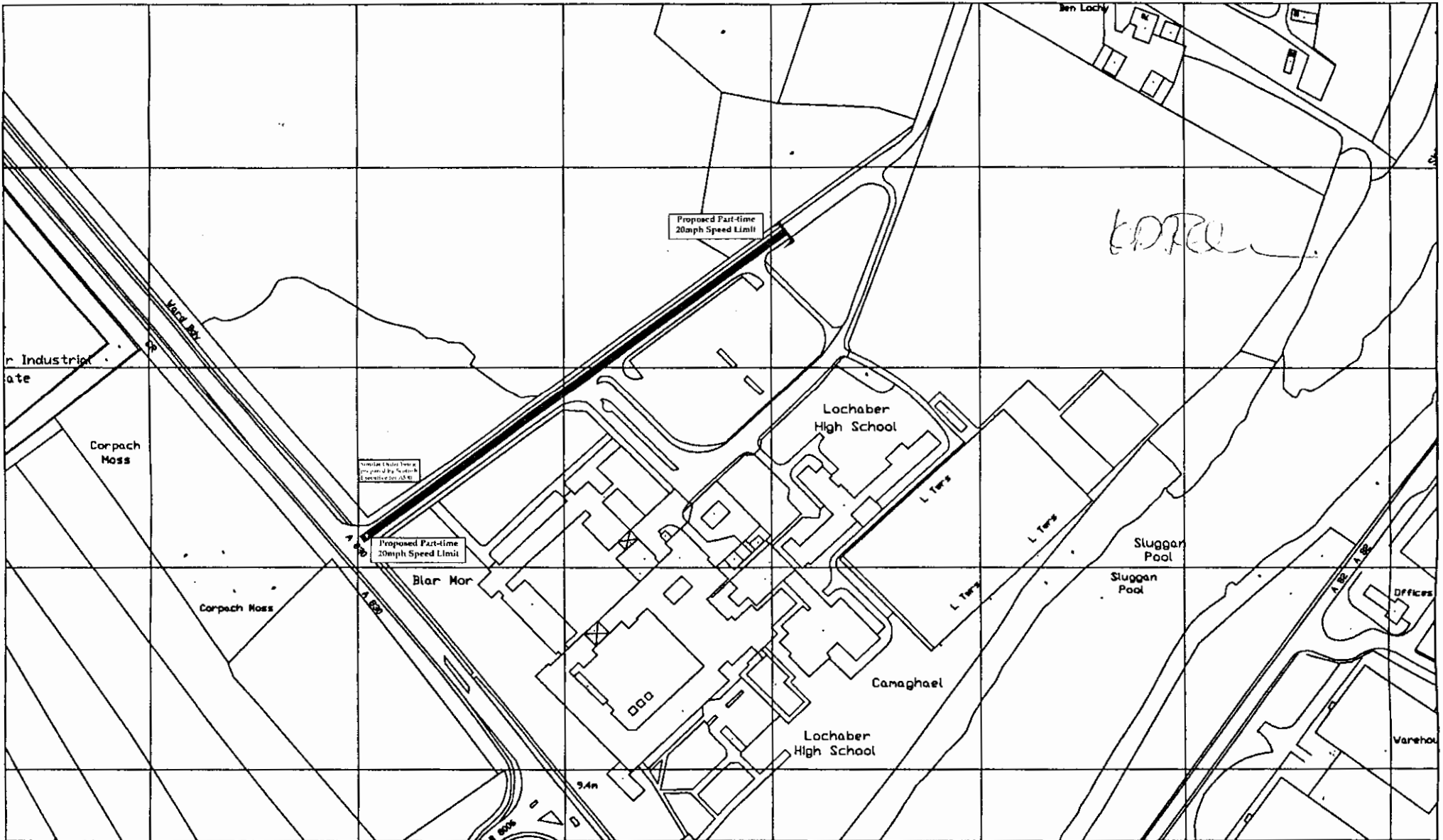
**Route C54 Corpach Moss Road (Northern Loop - Camaghael)**
