# 1 Membership FAQ's

## 1.1 How much does membership cost?

Membership costs £40 for 7 consecutive days and can be purchased directly from our website [www.highland.gov.uk/motorhome](http://www.highland.gov.uk/motorhome)

## 1.2 How can I purchase membership to the scheme?

The Highland Campervan and Motorhome Scheme website includes a link to purchase a membership. All purchases are made via our website [www.highland.gov.uk/motorhome](http://www.highland.gov.uk/motorhome)

## 1.3 Can I pay by DEBIT/CREDIT card?

Purchasing a Highland Campervan and Motorhome Scheme membership can only be completed using a debit or credit card via our website [www.highland.gov.uk/motorhome](http://www.highland.gov.uk/motorhome). We do not accept payment by any other method.

## 1.4 When I join the scheme – what will I receive?

Members will receive an email confirming payment and membership start date. Following purchase, we recommend you regularly check our website to keep up to date with the included benefits of the scheme. The 'News' section will also keep you up to date with information about the scheme. Please keep your email confirmation safe as this may be required to prove membership status to access some of the included benefits.

## 1.6 How long does membership of the scheme last for?

The Highland Campervan and Motorhome Scheme lasts for 7 days with the start date selected at the time of purchase.

## **1.7 Are there any options for shorter or longer stays?**

The Highland Campervan and Motorhome Scheme has launched with a single 7-day option for a fee of £40. This ensures the scheme is accessible and easily understood. People who are visiting for less than 7 days can purchase a pass for £40. Those who are staying for more than 7 days, and repeat visitors have the option to purchase multiple memberships throughout the year.

## **1.8 Can I cancel my membership?**

You can cancel your membership in advance of the selected start date. Once the membership activates there is no option to cancel your membership.

## **1.9 If I cancel my membership, will I receive a full refund?**

If you cancel membership before the start date you will receive a full refund. There is no option to cancel after the start date selected at the time of purchase.

## **1.10 I am travelling as a group or a family, do we all need to buy a membership?**

The Highland Campervan and Motorhome Scheme membership is linked to your vehicle so you would only need to buy a single membership per vehicle regardless of the numbers travelling in each vehicle.

## **1.11 What happens if I change vehicle?**

If you change your vehicle while your Highland Campervan and Motorhome Scheme Membership is active no action is required.

## **1.12 What happens if I need to change my personal details?**

You can amend your personal details using the 'Manage my Membership' link on the homepage.

## **1.13 Can I change the start date?**

If you need to change the start date you can cancel your membership using the 'Manage my Membership' link on the homepage. If the start date has not commenced, you will receive a full refund within 3 – 5 days. Please apply for a new membership with the required start date.

### **1.14 Are there any discounts available from the £40 charge?**

The £40 charge applies to all purchases made throughout the year. The pricing structure and benefits will be universal for all customers.

### **1.15 Is there a concessionary membership available?**

The Highland Campervan and Motorhome Scheme is designed to deliver universal pricing to ensure all customers receive the same value for money.

### **1.16 Can I purchase a scheme membership as a gift for someone else?**

There are currently no options to purchase a Highland Campervan and Motorhome Scheme membership as a gift for someone else.

## **2 General FAQ's**

### **2.1 What vehicle types are included in the Scheme?**

The Highland Campervan and Motorhome Scheme is open to anyone who stays in our network of dedicated overnight carparks. A map of sites can be found on our website [www.highland.gov.uk/motorhome](http://www.highland.gov.uk/motorhome)

### **2.2 I am renting a campervan or motorhome – should I contribute to the scheme?**

The Highland Campervan and Motorhome Scheme is open to all who will be parking overnight in a designated Council carpark. The scheme has been designed to work for rental customers as well as owners. The included benefits of the scheme have been selected to enhance your visit throughout the Highlands.

### **2.3 I live in the Highlands and pay local Council Tax, as a campervan/motorhome owner should I pay into the Scheme?**

The Highland Campervan and Motorhome Scheme is completely voluntary and open to anyone who would like to join. Council Tax contributes around 20% of the Council's overall budget for the provision of a wide range of statutory and non-statutory services. Vehicles used for overnight stays have environment and local impacts. Income from the Voluntary Scheme will contribute directly towards further infrastructure development that will be of mutual benefit to your local stays and local communities. By supporting the scheme, you will be able to take advantage of the included benefits during your trips in the Highlands.

### **2.4 Why has this Scheme been launched in the Highlands?**

We welcome Campervans and Motorhome visitors to the region to experience the hospitality, scenery, local products, and ecological experiences and much more. The Highland Campervan and Motorhome Scheme is designed to ensure that Highland continues to be a destination of choice by domestic and international visitors; tourism in the region is sustainable; and your journeys throughout the Highlands are enhanced. We shall invest to sustain and improve our existing infrastructure.

### **2.5 Why is the Scheme Voluntary?**

The Highland Campervan and Motorhome scheme is voluntary to provide choice and empower those touring and visiting the Highlands to enjoy the benefits that the scheme provides. We believe a voluntary scheme is likely to achieve a high level of support as income from the scheme will contribute to sustaining and improving the infrastructure which is essential for all road users and for the provision of overnight facilities.

## **2.6 Will the Scheme impact upon local businesses?**

The introduction of the Highland Campervan and Motorhome Scheme will support local businesses. Visitors are encouraged to visit nearby private businesses for wastewater disposal and to purchase from our many local retailers. Engagement and research has established that Campervan and Motorhome users will typically use sites like our overnight car park network for 2 – 3 nights before staying at more established campsites.

## **2.7 How is the Highland Campervan and Motorhome Scheme different from the proposed Visitor Levy?**

While the Visitor Levy is a national scheme which is likely to be implemented at the very earliest during 2026, the Levy is intended to apply to visitors staying in fixed overnight accommodation (Hotels, B&B's, campsites, etc.). The Highland Campervan and Motorhome Scheme is a voluntary scheme which has been designed by the Highland Council for the mutual benefit of those choosing to tour the Highlands and local communities. Membership of the scheme provides benefits while also helping to protect our region's ecology, communities, and local economy for the enjoyment of future generations.

## **3 Included Benefits FAQ's**

### **3.1 What benefits are included with the scheme?**

The Highland Campervan and Motorhome Scheme includes the following benefits which have been selected to enhance your visit to the area:

- Inclusive overnight parking at our network of designated car parks (See Map of Sites on the website [www.highland.gov.uk/motorhome](http://www.highland.gov.uk/motorhome))
- Contribution to the Highland Restoration Fund which is designed to help support projects that will deliver nature restoration, safeguard wildlife, and tackle the causes of biodiversity loss due to climate change – this is initially set as 1% for every £100K of income generated
- Direct investment for sustainable tourism and to enhance visitor experiences
- An investment fund of £2.25M has been committed by the Council to improve existing infrastructure and to provide more Council owned sites
- Free daily access to showering and changing in any High Life Highland leisure location (external link) during normal opening hours – for 2 adults and an unlimited number of children

### **3.2 How many overnight car parks are available?**

The network currently has 12 designated sites located around the Highlands. We recommend visitors slow down their journey and visit some of the less well-known sites around the route.

### **3.3 Will there be more overnight car parks available in the future?**

It is likely that the network of overnight car parks will expand in future years. The extent to which the networks will grow will be dependent upon the ongoing success of the Highland Campervan and Motorhome Scheme.

### **3.4 When I stay in an overnight car park will I still need to pay for daytime charges?**

Yes, the daytime charges are still applicable, and it is important that you vacate the overnight car park before the daytime rates become applicable.

### **3.5 Is there a booking system for overnight parking spaces?**

There is not a booking system in place. We have used a traffic light system on our website [www.highland.gov.uk/motorhome](http://www.highland.gov.uk/motorhome) to detail which overnight car parks are likely to reach capacity during busier periods.

### **3.6 For overnight parking will I need to use the ticket machines?**

If you paid £40 to purchase membership of the Highland Campervan and Motorhome Scheme, overnight parking is fully inclusive. This means you will not need to purchase a ticket and will not have to interact with ticket machines.

### **3.7 Where is there access to public toilets?**

The sitemap on our webpage [www.highland.gov.uk/motorhome](http://www.highland.gov.uk/motorhome) indicates the nearest public toilet. There are also links to the full public toilet network to help you plan which sites are most convenient as you travel around the Highlands. We ask all users to leave every site as they found it.

### **3.8 How do I dispose of waste and wastewater?**

The sitemap on our website [www.highland.gov.uk/motorhome](http://www.highland.gov.uk/motorhome) indicates the nearest recycling centre and wastewater disposal point for each overnight car park. There are also links to the waste and wastewater network to help you plan which sites are most convenient as you travel around the Highlands. We ask all users to leave every site as they found it and ensure that all wastewater is disposed of at an official site.

### **3.9 Will the included benefits change over time?**

The Highland Campervan and Motorhome Scheme will evolve over time to include more benefits. Based on feedback from our members of the Scheme and other data, we will regularly review the scheme to ensure it meets the needs of those visiting and touring the Highlands, while also aiming to provide our communities with local infrastructure and services.

### **3.10 What is the Nature Restoration Fund?**

Established by the Scottish Government, the Highland Council Nature Restoration Fund (NRF) is a capital fund designed to help support projects that will deliver nature restoration, safeguard wildlife, and tackle the causes of biodiversity loss due to climate change.
