### The Highland Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Variation Ten Attadale Road, Inverness Order 2024

Notice is hereby given that The Highland Council (“the Council”) in exercise of its powers under Sections 1(1), 2(1) to (3), 4, 19, 32, 35, 45, 46,47 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”) and the Road Traffic Act 1991 (hereinafter referred to as “the 1991 Act”) and of all other enabling powers proposes to make an Order entitled as above the general effect of which is as described in the Schedule below.

Statement of Reasons

The Council in exercise of the powers conferred on them by Sections 1(1) and 2(1) and 2(2) of the Road Traffic Regulation Act 1984 proposes to make an order facilitating the provision of Permit Holder parking as scheduled within the Order.

The effect of the Order will specifically address congestion and issues relating to parking management experienced on the residential street Attadale Road, Inverness

- This order will: Introduce on-street parking, waiting and loading restrictions on Attadale Road and “Permit Holder Only” bays will be introduced.

This Order will also allow for the enforcement of any contraventions or offences relating to the waiting and loading restrictions described in the Order.

## ROAD TRAFFIC REGULATION ACT 1984

### **The Highland Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Variation Ten Attadale Road, Inverness Order 2024 - DRAFT**

THE HIGHLAND COUNCIL in exercise of its powers under Sections 1(1), 2(1) to (3), 4, 19, 32, 35, 45, 46,47 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act of 1984”) as amended and of the Road Traffic Act 1991 (“the 1991 Act”) and of all other enabling powers, and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on the \_\_\_/\_\_\_/2024 and may be cited as “The Highland Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Variation Ten Attadale Road, Inverness Order 2024”
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act of 1984 or by or under any other enactment provided that where a prohibition or restriction which is imposed, varied or revoked by this Order is in conflict with a prohibition or restriction imposed by a previous Order, then the provision of this Order shall prevail.
4. If a court, Transport Scotland or the Parking and Bus Lane Tribunal Service for Scotland, declares any part of this Order to be invalid or un-enforceable, such declaration shall not invalidate the remainder of this Order.

5. The Highland Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Order 2016 as amended (hereinafter referred to as the “Principal Order”) is hereby varied as follows: (i) the plans specified in Schedule 1 to this Order are deleted from the Principal Order and the plans annexed and signed as relative to this Order and listed in Schedule 2 to this Order are substituted therefor and hereby added and incorporated into schedule 1 to the Principal Order; (ii) the following wording is added to Table 3.1 of schedule 3 to the Principal Order: “Attadale Road, Inverness”.

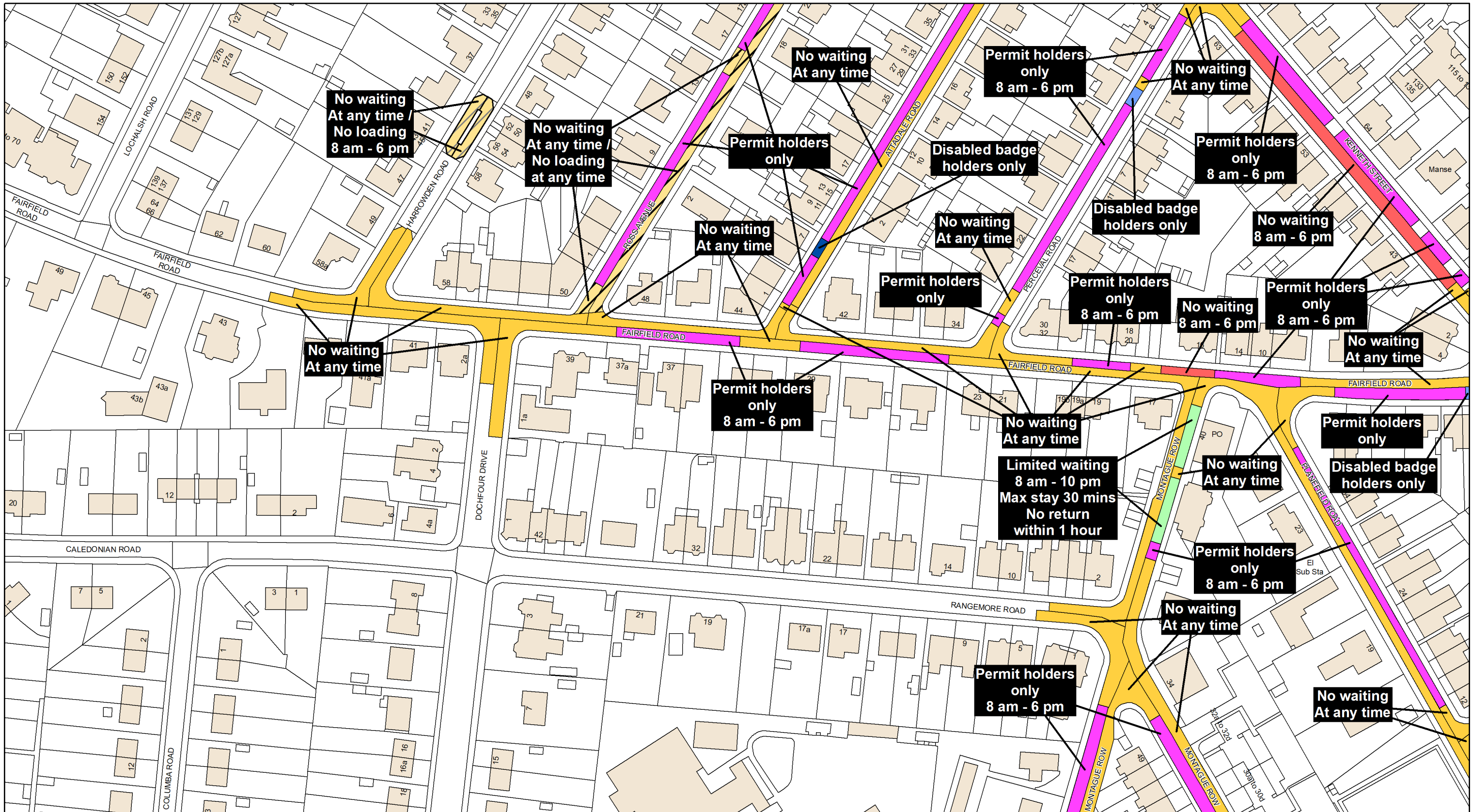

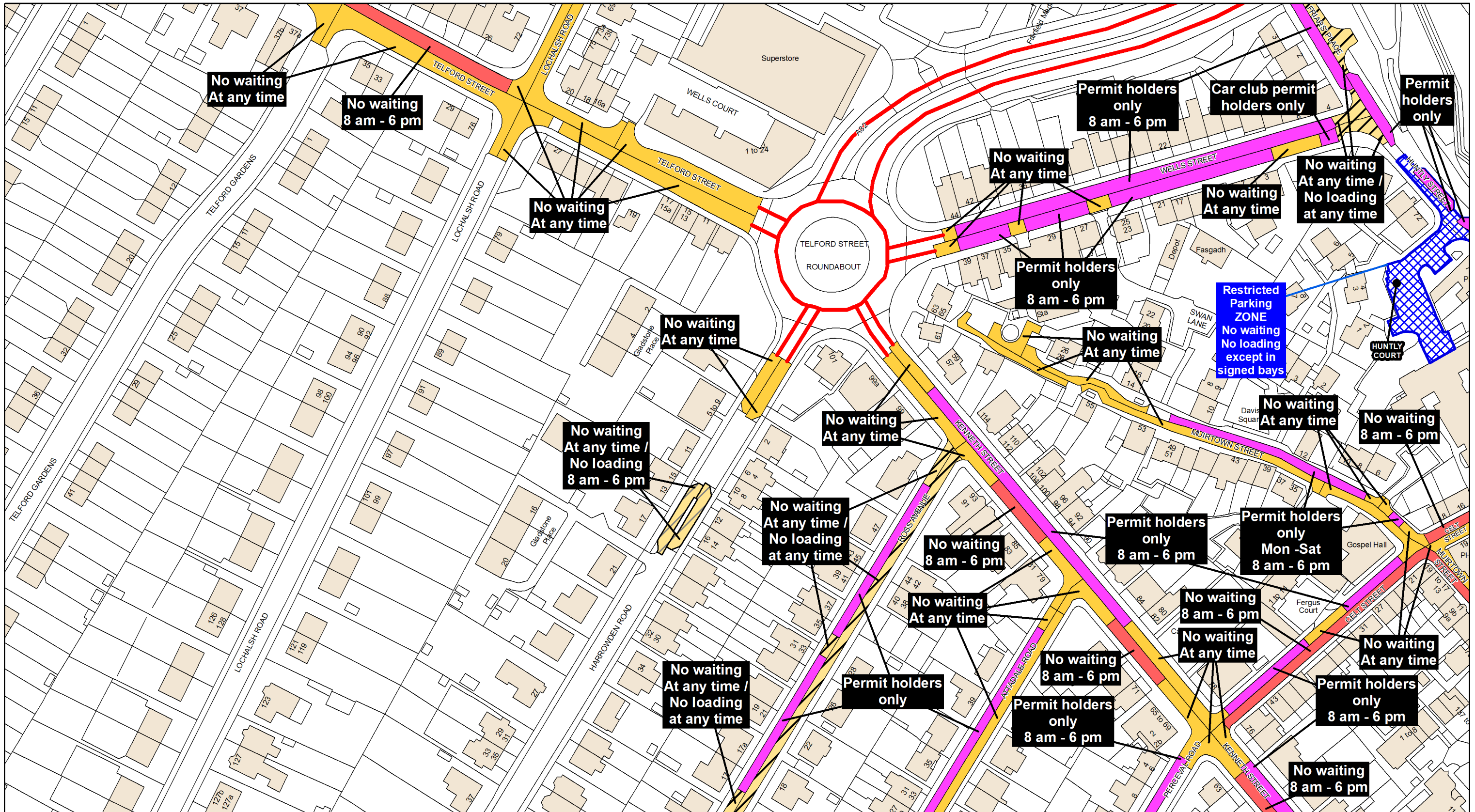
