History of our School

Lochinver Primary School is situated in a rural area on the West coast of Sutherland. It serves the village of Lochinver as well as the outlying areas of Achmelvich to the North, Inverkirkaig to the South and Elphin to the East.

The school is housed in the old village school which has been extended over the years. It has two classrooms, a GP room, a library, an office, staffroom and canteen.

There are extensive playgrounds providing tarmac and grassy areas for learners at break-times.

Since August 2023 the school have been running their own Early Learning Centre which is in a separate building on the school grounds.

During the academic session 2024/25 we are working with our estates officer and other partnerships within the community, to upgrade parts of the school to suit the growing community.

Absence from School

Good attendance is vital for pupils to help them achieve their full potential. If a pupil is absent from school, a parent or carer should make contact with the school on the first day. This can be done by calling, emailing or by sending a message on seesaw.

For longer absences please contact the head teacher to make them aware – William.Stephen@highland.gov.uk

If a pupil was to fall ill during the school day, we would make contact by telephone to ask for your child to be collected. Therefore, it is essential that we have the most up to date contact numbers and emergency contact details.

Schools are required to keep an attendance register by law. We have a responsibility for the care and welfare of all pupils during the school day therefore need to know the whereabouts of absent pupils.

When parents are considering whether or not to remove their children from school for a family holiday, they should be aware that such a decision:

- Will result in a significant loss in classroom experience.
- Will result in a pressure to 'catch up' on missed work by pupils.
- Could result in pupils missing assessments with consequential impact on pupils and teachers.
- Could result in the loss of curricular activities.
- Will affect school attendance records and efforts to raise standards of attendance.
- Under the guidance issued at a national level, most family holidays will be coded as unauthorised absence, only in exceptional cases will the absence be recorded as authorised.

In conclusion, we would ask parents to be aware of these considerations when making decisions on planning holidays during term time. We have enclosed a link to the school term dates on the Highland Council website to aid parents in planning any holidays they may be considering.

School Term Dates

If parents decide to make holiday arrangements during school term, this should be confirmed in writing to the Headteacher.

Access to Pupil Records

The Pupils' Educational Records (Scotland) Regulations 2003 extend to parents the right of access (with certain specific exceptions) to any record held by the Authority in relation to their child. Parents may make application to the Headteacher.

Administration of Medicines

National Guidance on the Administration of Medicines in Schools has been issued by the Scottish Government. <https://www.gov.scot/publications/supporting-children-young-people-healthcare-needs-schools/>

This guidance is based on a number of common principles that will be consistently applied when identifying, supporting and reviewing the healthcare needs of children and young people in Highland schools to enable them to make the most of their learning.

Under Article 24 of the United Nations Convention on the Rights of the Child, all children have a right to the highest attainable standard of health and to health care services that help them attain this. Article 7 of the United Nations Convention on the Rights of Persons with Disabilities states that children with disabilities have the right to express their views freely on all matters affecting them. The arrangements for each individual will therefore take account of the health professionals' advice, the pupil's views and, where appropriate, their parent's views.

NHS Highland, Highland Council and school staff will work collaboratively to ensure that pupils receive the service they need in the way most appropriate to their personal circumstances.

We will work with pupils and parents/carers to support the healthcare in our school, making reasonable adjustments that children and young people with healthcare needs might need and require.

Where appropriate, we will make arrangements for staff providing healthcare to pupils to receive appropriate training from a health professional, or other accredited source in the care they are providing.

Assistance with intimate care may be needed by children in any school and this will be provided if required to support these needs quickly and with respect for children's privacy, dignity and rights.

If your child requires medication, please note that this will only be administered by staff when there is clear written guidance from a parent/carer, providing:

- The name of the medicine, the quantity of the medicine to be given, the time it has to be given.
- As far as possible prescriptive medication should be given at home by parents/carers. If it is required to be given in school, the medication should be unopen, clearly marked with the directions from the pharmacist and administered as part of an agreed medical protocol.

Adverse Weather – School Closures

This is in addition to the Highland Council website being updated. We aim to let you know of closures as soon as possible through Seesaw. An official text message will also be sent to the learner's main contact.

If the school was to close during the school day, we would message all parents and also make arrangements for you to be contacted by phone.

Assembly/Religious Observance

The school has regular assemblies where we celebrate the successes and achievements of our school community. We value all religions, cultures and beliefs and welcome visitors from different religions to our assemblies. If you do not wish your child to take part in religious observance, please let us know. Alternative arrangements shall be made.

Assessment and Reporting

As a school, we seek to provide information to pupils, parents and staff to assist in the effectiveness of learning and teaching process and in raising attainment.

Teachers will use the assessment process as an evaluative, diagnostic and formative tool to provide evidence of pupil attainment and progress and to inform learning and teaching approaches and pupil targets.

Pupils should view the assessment process as a motivating experience which takes place within the overall context of a supportive school. Pupils should make use of feedback, in all its forms to inform next steps for the improvement of their own learning. Parents will receive feedback on their son or daughter's progress through pupil reports, progress checks, and target setting information.

Pupils will reflect on their progress, achievement and best work on their profiles.

Progress

Parents wishing to enquire about a pupil's progress are invited to get in touch with William Stephen (Head Teacher).

We currently have two parents evening per academic year usually one before the October holidays, and another before the Easter holidays. End of year report cards will be sent out in June.

Bullying

The school is fully committed to eliminating any bullying which takes place. Staff in the school attempt to foster in children, both through teaching and in social situations, the value of fairness and respect and the idea that the feelings and wishes of every child are equal importance. Bully can be defined as wilful, conscious desire to hurt, threaten or frighten someone else. If bullying occurs, the incident will be taken very seriously, and action will be immediate. Pupils and parents are encouraged to let staff know immediately if a problem occurs, so that early intervention can take place.

All incidents of bullying are recorded, actioned and monitored.

Curriculum throughout the School

The Curriculum for Excellence aims to achieve a transformation in education in Scotland by providing a coherent, more flexible and enriched curriculum from 3 to 18. The curriculum includes the totality of experiences which are planned for children and young people through their education, wherever they are being educated.

In Achiltibuie and Lochinver we follow national guidance on what to teach. We believe that children learn best when they are motivated, challenged and can see the relevance in what they are learning. The Curriculum for Excellence has eight distinct subject areas but there is an expectation that subject material will be delivered in a cross-curricular manner where this is appropriate. Your child will therefore encounter some subject matter being taught in discreet ways, whilst other material may form part of a topic that covers a range of subjects.

The 8 curricular areas within the Curriculum for Excellence are:

- Mathematics and Numeracy
- Literacy and Languages
- Health and Wellbeing
- Social Studies
- Sciences
- Technology
- Religious and Moral Education
- Expressive Arts

We aim to develop our pupils into successful learners, confident individuals, responsible citizens and effective contributors.

Curriculum for Excellence Levels provide a very broad indication of how children progress in their learning from ages 3 to 18. Expected levels of progression are as follows:

Level	Stage
Early	The pre-school years and P1, or later for some.
First	To the end of P4, but earlier or later for some.
Second	To the end of P7, but earlier or later for some.
Third & Fourth	S1 to S3, but earlier for some.

Learning and Teaching

Every school day is different depending on the activities and events happening that week. However, we use the Curriculum for Excellence for planning our lessons and strive to be successful teachers by using the following principles from young people within the Highland council, all teachers aim to be respectful, open, aspirational, assertive, encouraging, enthusiastic and humorous. Teachers work with a mixture of groups and individuals on a day-to-day basis. Each term we use inter-disciplinary topic planning to ensure the children partake in a range of experiences

and are engaged. Further information on the curriculum can be found using the link below:

Mathematics and Numeracy

The teaching of mathematics includes Number, Money and Measure. Share, Position and Movement. Problem-Solving and Information Handling.

We use TeeJay Maths & White Rose Maths, supplemented by a bank of teacher-prepared materials which relate to real life situations. Learners work through a variety of activities from early years to become familiar with appropriate mathematical vocabulary. We use websites such as Sumdog, and Topmarks Maths to reinforce mathematical concepts.

We ensure that our practice is up to date by working closely with the Numeracy Support Officer and participating in appropriate training. We follow the Highland Numeracy Progression and have assessment procedures in place using the Highland Diagnostic Assessments.

Literacy and Languages

Literacy is fundamental to all areas of learning. Language development in the school includes the four elements of reading, writing, talking and listening.

Talking experiences include exploring sounds, patterns, rhythm, rhyme to be able to communicate effectively with others. This includes taking turns to talk and being able to respond to others.

Listening experiences include the development of listening and attention skills, phonological awareness, listening for information and listening to follow instructions.

Reading consists of core reading sessions 3-4 times per week, reading for enjoyment, reading for information and the sharing of class novels, poems, and short stories to develop a love of literacy and extend vocabulary.

Writing is a current focus for improvement through the implementation of Talk for Writing across the school. Handwriting begins with mark-making and when ready, letter formations are taught. From P3, the children are taught to join their handwriting. Spelling is an ongoing focus, through the use of wraparound spelling approaches.

Modern Languages

Learning another language allows pupils to explore other cultures and to extend their global citizenship. We teach include French, Gaelic and BSL. All stages are involved and work at their own level and we teach through a wide range of activities including

songs, games, role-play and direct teaching of simple vocabulary and language structures.

Health and Wellbeing

Health and Wellbeing is central in ensuring our young people develop physically, emotionally, socially, and mentally. Learning in health and wellbeing ensures that children and young people develop the knowledge and understanding, skills, capabilities and characteristics which they need for mental, emotional, social and physical wellbeing now and in the future.

Learners enthusiastically participate in weekly PE sessions with a specialist teacher from Ullapool Highschool, who comes and covers class teachers non-contact time.

We follow the plans as suggested by the Highland council for the relationship aspect of the programme. We also ensure we try to take a nurturing approach in the school and involve the children in a wide range of activities to teach them how to keep themselves and others safe.

An annual Sports Day is organised in the summer term and senior pupils represent the school at various interschool sports events throughout the year. We are able to provide swimming lessons for all pupils at the Lochbroom Leisure Centre in Ullapool.

Religious and Moral Education

Pupils will learn about the wide range of beliefs in Scotland, they will also study the major world religions as well as beliefs that lie out with religious traditions. Within this process, pupils will engage in the search for meaning, value and purpose in life. The teaching of RME is accomplished through regular bible stories, songs, hymns, discussion aided by personal research and textbooks. A cyclic programme is available to provide a variety of topics. Christian festivals are included when a programme of work is planned. Festivals & Celebrations from the six main religions are integrated into topic work where appropriate.

We hope to give pupils an awareness and understanding of the beliefs, values and practices of Christianity and in particular the life and work of Jesus. Tolerance and understanding of the diversity of other faiths and their beliefs will assist in counteracting prejudice and discrimination in our society. Religious and Moral Education is therefore an essential part of every child or young person's educational experience. RME has a statutory position in Scottish Education.

Pupils may be withdrawn from Religious Observance at their parents' request.

Expressive Arts

The Expressive Arts include experiences in art and design, drama, dance and music.

Music: All learners are encouraged to enjoy listening, creating and performing music. Learners may use the school instruments or bring in their own. Throughout the year we have music input from an instructor, provided by Feis Rios, this is part of the Youth Music Initiative. The younger learners also get the opportunity to take part in Kodaly- both in blocks throughout the year. Pupils will be given opportunities to play instruments from P1. Practice in school and particularly at home is to be encouraged. We try to link musical activities into our classwork. We also plan musical / dramatic presentations within our annual programme. Chanter or drumming Instruction is offered weekly to pupils from P4 upwards. Pupils have a record sheet to aid regular practise. Extra-curricular music lessons are available in accordion & whistle.

Art and Design: learners work within the school's curricular programmes incorporating aspects of Art & Design within the levels. Planned opportunities are provided for pupils to work with a variety of materials and techniques. The main aim is that pupils can express their ideas freely.

Drama: Learners are encouraged to link up their learning experiences by free expression through imaginative play acting, miming, debating or just dressing up. Older pupils may choose to write short plays within topic or language work then having the opportunity to stage it for the other learners.

Social Studies, Sciences & Technology:

Much of this work will be approached through topics and will be taught in an integrated way. In all such studies, we are concerned not only with factual content but also with the development of skills, ideas, and attitudes through which real understanding is achieved and which will form the basis for future study. We aim to develop enterprising attitudes and skills and we encourage curiosity, independent thinking, and positive attitudes to entrepreneurship.

Informing Parents About Sensitive Aspects of Learning:

At Lochinver Primary School, we understand the importance of keeping parents informed about sensitive aspects of learning. Topics such as relationships, sexual health, parenthood, and drugs awareness are introduced as part of the Curriculum for Excellence in an age-appropriate and sensitive manner. Parents will be informed in advance when these subjects are scheduled, including details of the content and delivery. We value parental input and will provide opportunities to discuss any concerns or questions during scheduled meetings or via direct communication with the class teacher. Parents wishing to view the materials used can request access through the school office.

Data Protection Legislation

Information on pupils, parent and guardians is stored on a computer system and may be used for teaching, registration, assessment and other administrative duties. The

information is protected by data protection legislation and may only be disclosed in accordance with the codes of practice.

Transferring Educational data about pupils

The Scottish Government and its partners collect and use information about pupils through the *Pupil Census* to help to improve education across Scotland. Data policy

Information about pupils' education is collected through our statistical surveys in partnership between the Scottish Government and Local Authorities through the ScotXed Programme which aims to help schools and Local Authorities by supporting efficient collection, processing and dissemination of statistical information. The Scottish Government then provides analysis of the data to support research, planning, management and monitoring of education services as well as to produce National Statistics publications.

Education data within Scottish Government is managed effectively by secure systems and is exploited as a valuable corporate resource, subject to confidentiality restraints. As part of its data policy, Scottish Government will not publish or make publicly available any information that allows individual pupils to be identified, nor will data be used by Scottish Government to take any actions in respect of individuals. Data is held securely and no information on individual pupils can or would be made publicly available by Scottish Government.

The individual data collected by Scottish Government through the Pupil Census is used for statistical and research purposes only.

Education Maintenance Allowances (EMA)

An EMA is a weekly payment worth up to £30 for pupils who are planning to stay on at school after their leaving age. They must complete a learning agreement at school for a minimum of 21 learning hours per week.

In session 2025/2026 pupils born between 1 March 2006 and 30 September 2009 can receive payments from August 2025. Pupils born between 1 October 2009 and 28 February 2010 can receive payments from January 2026. Mental Health and Wellbeing

Staff will support the emotional development and wellbeing of pupils through formal and informal curricular activities. Any concerns about a pupil's wellbeing can be discussed with the named person. We understand some of the challenges that mobility of service life can bring, and we look forward to working with you to ensure a smooth transition for your Child/Young Person coming into or moving on from our School or Early Years setting. In Lochinver Primary we have a supportive and strong Parent Council. As a group we meet once per term to discuss improving outcomes for our pupils, planning events, and collaborating on school improvements, and discussing any current concerns.

We really value and welcome parents’ involvement in our school and are keen to work with you to help us give your child the best education and learning experience. The Scottish Schools (Parental Involvement) Act 2006 is seen as a key step in improving parents’ involvement in their own child’s education and in the wider work of the school. All evidence shows that when parents, carers and other family members are actively involved in supporting their child’s education, children’s achievement and general experience of school are better.

As a member of the Parent Forum:

- You can ask the school for advice and information on your child's education and how you can support this.
- You will have the opportunity to come along to meetings and to feed in your ideas in other ways.
- You can also help choose the Parent Council for your child's school – this is a group of parents who represent the views of parents in the school.

The type of things a Parent Council could get involved in includes:

- Supporting the work of the school
- Gathering and representing parents' views to the Head teacher, education authority and HMle
- Promoting contact between the school, parents, pupils, providers of nursery education and the local community
- Fundraising
- Organising events
- Being involved in the appointment of senior staff

Parents as Partners

We believe that much of the strength of the school lies in the positive relationships between staff, pupils and their parents. These relationships must be nurtured by a healthy exchange of information between teachers and pupils, between home and school. We always welcome parental interest in the welfare of our pupils. Whatever the nature of the issue, you can be assured of our help.

The school works very hard to keep parents informed regarding their child's progress and any key decisions being made about their education. This includes:

- Face-to-face Parent Evenings
- Stay and Play Sessions
- Child Plan Meetings
- Learning Targets for Literacy & Numeracy
- Communication through seesaw

The support of parents in their children's education is key to the success of young people. Taking time with them, discussing work, practicing language, helping them manage their homework and encouraging responsibility are important ways of supporting children's learning. If you have any questions regarding supporting your child at home, please reach out to the class teacher – who will be able to assist.

The school always seek to involve parents in any key decisions about their child's education and keep parents informed about progress.

Parental information is obtained from questionnaires issued regularly at Parents evenings and from Parent Forums.

Protection of Children

From time-to-time incidents can occur within the school setting which cause concern and could indicate that a pupil is suffering some form of abuse.

In terms of Highland Child Protection Committee Inter-agency Protection Guidelines, Education Service staff must report such incidents to Social Work Services which can lead to a joint Social Work/Police investigation.

All agencies involved in Child Protection are obliged to make the welfare of children their paramount consideration and this will be the priority for Education Service staff.

Pupil Council

Due to school roll size, we have amalgamated groups within the school (Pupil Council, Eco Group & Junior Road Safety Officers). Often learners will meet with the Head Teacher to discuss school issues and developments. Members bring requests and suggestions to put forward.

During each meeting an action plan is created during collaboration.

School Placing Requests – Parental Choice

Each school serves its own particular catchment area. Pupils whose homes are located in that area will have priority in being allocated a place in the school. However, parents have the right to specify the school in which they wish to place their child. Applications are made to the Area Education and Learning Manager Mhairi MacDonald. Transportation to and from school, for placing request pupils, is a parental responsibility.

If pupils live out with the school catchment area and their parents wish them to attend either Achiltibuie or Lochinver Primary they can contact William Stephen to arrange a visit.

Parents of children with additional support needs, (including those that have Coordinated Support Plans) can make placing requests to any school in Scotland including schools outside of the local authority area they live in. All appeals about placing requests to special schools will be referred to the Additional Support Needs Tribunal.

School Transport

Your child may be eligible for free school transport if they are:

- Under 8 and live more than 2 miles from school
- 8 or over and live more than 3 miles from school
- Have a medical condition or additional support needs that affects mobility
- Would have to walk a route which is considered by us to be unsafe for children to walk, even when accompanied by an adult

Note that transport is not necessarily be provided door-to-door and there may be a requirement to meet transport at a pickup point.

Support for Learners

All children need support to help them learn, and, at times, some children require more help than others. We follow The Highland Practice Model staged approach to assessing, identifying and supporting additional support needs. In this model every child has a 'named person' who is responsible for making sure that the child or young person has the right help to support his/her development and well-being.

If you have a concern about your child in primary school please contact your child's class teacher in the first instance or the 'named person', who will usually be the head teacher. Sometimes a Child's Plan may be put in place to help organise, monitor and regularly review your child's progress. We aim to make effective provision for pupils with additional support needs by meeting pupils' individual needs and helping pupils to make the best use of their abilities and educational opportunities. Children who have additional support needs require sympathetic and flexible teaching. The class teacher, parents, and school community need to foster a sense of understanding, support and encouragement.

Parents of children with additional support needs will be consulted at an early stage in the consideration of their child's difficulty. If the assessment of a child by the Educational Psychology Service or Speech and Language Service is deemed necessary then the parent will be consulted prior to referral.

Sometimes a Children's Service Worker will be involved in supporting a child. A Children's Service Worker visits the school regularly and will generally focus on more social and emotional needs rather than issues about the curriculum or classroom learning. They:

- work in collaboration with the support team in school
- work to support families in their own communities
- work with individual pupils and small groups - offering a further level of support

Council would seek to work in partnership with parents at all times, but sometimes you will have a concern that you don't feel is being addressed, or will want to talk to someone out-with the school. Should you have any concerns that your child's additional needs are not being met, you should contact the Head Teacher. If your concerns continue, there are a number of means of resolving difficulties and disputes and information on this can be found at:

Transitions into Primary 1

All Primary 7 learners from Achiltibuie & Lochinver Primaries and surrounding Primary Schools will get the chance to attend and/or host several social activities.
