#### Summary

This Report relates to applications which are currently pending for the grant or renewal of licences under the Civic Government (Scotland) Act 1982.

#### 1.0 Background

1.1 In terms of Section 3(1) of the abovementioned Act all applications require to be determined within 6 months of their application date otherwise the licences will be granted unconditionally for a period of 12 months. Furthermore all applications which have not been dealt with within 3 months must be submitted to the Licensing Committee for consideration.
