Street naming – New development at Kirkhill; Kiltarlity; and Milton of Leys, Inverness

Summary

The Committee is asked to homologate decisions by the Community Councils, supported by the local Members, to name:

- two distributor roads at Milton of Leys:
 - Milton of Leys Road (*Rathad Bhaile Mhuilinn an Leigheis*)
 - Braes of Balvonie Road (*Rathad Bràigh Bhaile a' Mhonaidh*)
- two residential streets at Milton of Leys:
 - Silver Birches (*Beithean Geala*)
 - Copperwood Drive (*Dràibh na Coille Copair*)
- one street in Kiltarlity that currently has built units:
 - Old Mill Road (*Rathad an t-Seann Mhuilinn*)
- two streets in Kirkhill that currently have built units:
 - Aird View (*Sealladh na h-Àirde*)
 - Aird Crescent (*Corran na h-Àirde*)

1. Background

- 1.1 The Council's Corporate Address Gazetteer (CAG) Team within the Development and Infrastructure Service was asked by the developers who were building residential properties, to create an address for the new roads.

2. Consultations

- 2.1 The CAG Team determined that there should be street names. A request was sent to the Ward Manager to consult with the Community Councils and local Members who all agreed that the streets be called as follows:

- two distributor roads at Milton of Leys:
 - Milton of Leys Road (*Rathad Bhaile Mhuilinn an Leigheis*)
 - Braes of Balvonie Road (*Rathad Bràigh Bhaile a' Mhonaidh*)
- two residential streets at Milton of Leys:
 - Silver Birches (*Beithean Geala*)
 - Copperwood Drive (*Dràibh na Coille Copair*)

- one street in Kiltarlity:
 - Old Mill Road (*Rathad an t-Seann Mhuilinn*)
- two streets in Kirkhill:
 - Aird View (*Sealladh na h-Àirde*)
 - Aird Crescent (*Corran na h-Àirde*)

3. Delegation to City/Area Committees

3.1 As per the Scheme of Delegation the final decision on Street and Building Naming is delegated to the Area/City Committees. However in this instance the properties at Milton of Leys and Kiltarlity had been handed over to customers and at Kirkhill were being handed over to customers on early March. We therefore had to act on what had been agreed with the Community Councils and local Members and bring the matter to the Area Committee for homologation.
