Street Naming – Development at Ness Gap Fortrose

Report by Head of Policy and Reform

Summary

The committee is asked to determine the name for two streets within the new development of 20 properties at Ness Gap, Fortrose.

1. Background

- 1.1 The Council's Corporate Address Gazetteer (CAG) team within the Development and Infrastructure Service was asked to create addresses for two streets names within a 20 house development at Ness Gap, Fortrose.

2. Consultations

- 2.1 The Corporate Address Team requested that the Ward Manager consult with the Community Council and Local Members, with a view to determining two street names for the 20 house development.
- 2.2 The Developer did not make any suggestions in relation to the Ness Gap Fortrose Development.
- 2.3 The Ward 10 Members (excluding Councillor Jennifer Barclay who declared an interest and has taken no part in the process) made a recommendation at a recent meeting with Fortrose and Rosemarkie Community Councillors that the names Barclay and Matheson be reflected in the names chosen for the two streets.
- 2.4 Street naming was not discussed by the Community Council at its meeting on 13 January 2016 but subsequently the Community Council has proposed that the two street names be Dolphin Drive and Fort George Walk.
- 2.5 There is no unanimous view from Ward 10 Councillors as to whether or not to endorse this proposal.

3. Delegation to Local Committees

- 3.1 The Scheme of Delegation grants the final decision on street and building naming to Local/City Committees.
