A seizure occurs when - alcohol, and/or; tobacco product, and/or; cigarette papers are surrendered, or are removed from an individual by a Police Officer, for the purpose of safeguarding the health and well-being of that individual or any other, in circumstances where the stop and search tactic has NOT been utilised and no physical search of an individual has taken place.

The ACT NOW for schools project consists of four lessons exploring issues surrounding terrorism, It centre around a fictitious table top exercise delivered by external community facilitators with support from the local police. The lessons also cover political and historical terrorism and human safety versus human rights. The purpose of ACT NOW for schools is to encourage diverse communities to understand counter-terrorism issues and to feel confident about making decisions based upon the information they are given.

ACT (All Communities Together) Now presentations delivered to all senior pupils at Ardnamurchan High School.

WRAP (Workshop to Raise Awareness in Prevent) training delivered to Highlife Highland in Caol/Fort William during July 2017. WRAP training delivered to students at West Highland College during October 2017.

Prevention and Intervention Activity	<p>The Banking Protocol is an initiative between the police, banking institutions & Trading Standards. Its aim is at the earliest opportunity to identify vulnerable victims who are in the process of being defrauded of funds from their bank accounts by unscrupulous criminals and to intervene to prevent these crimes.</p> <p>Victims, particularly elderly and other vulnerable people are targeted by suspects for a range of fraud offences, including courier fraud and bogus worker offences. These crimes often involve the perpetrator encouraging the victim to attend their bank, post office or other financial services provider in person and withdraw or transfer cash.</p> <p>The Protocol is designed to provide a standardised method for how these concerns are dealt with and reported to police and to stop multiple victimisation. This protocol commenced nationally and in the Lochaber region during March 2018.</p>
