Objective – With Partners work to safeguard the Highland area by taking all opportunities to prevent crime and make the Highland area a hostile environment for Serious & Organised Crime Groups; to improve outcomes for individuals and communities and reduce offending through prevention, early intervention and diversion; in support of our Partners in the Local Authority and NHS via the Highland Alcohol and Drug Partnership Strategy we will direct those who are substance dependant towards recovery through prevention, treatment and support services; with Partners work to reduce the instances of substance misuse in our communities

<p>Serious & Organised Crime</p>	<p>Divisional Operation - Intelligence development and investigation into drug supply and use in educational establishments throughout the N Division area, including Nairn. All intelligence continues to be monitored daily and passed to the Area Inspector for a proactive approach.</p> <p>Divisional Operation – Ongoing investigation into recent online/electronic frauds which have targeted local business/charities and have resulted in the loss of substantial amounts of money in the Division and in the Nairn area over the current reporting year.</p>
<p>Prevention and Intervention Activity</p>	<p>There has been 3 Misuse of Drugs Act 1971 search warrants executed so far this reporting period.</p>

PRIORITY – Acquisitive Crime

Intention – Reduce crime through preventing offending and reducing re-offending

Objective – With Partners, share information, support education, prevention, diversionary and enforcement activity linked to acquisitive crime; develop work with targets – recidivist offenders to reduce reoffending linked to acquisitive crime e.g. Persistent Offenders programme; enhance the use of all media platforms to raise awareness of local and national preventative initiatives.

Prevention and Intervention Activity	<p>The COVID-19 lockdown in Nairn’s communities brought out and continues to bring out the best in the majority of the population. Communities have provided support to vulnerable residents and have all collectively looked out for neighbours. However, it was and remains important to highlight that less scrupulous individuals’ may seek to exploit people’s vulnerabilities.</p> <p>National and local online messaging encouraged people to think about their personal safety and encouraged individuals to be vigilant about who they engage with and accept assistance from.</p>

Intention – Engage with the public and communities to reduce and prevent crime

Objective – Work with partners to share information, support Education, Prevention, Diversionary and Enforcement Measures linked to harmful alcohol consumption; maintain robust procedures around licensed premises; support victims of violent crime by working with partners to improve service provision and prevent repeat victimisation.

<p>Positive Stop Search - A positive stop and search is when an item is recovered where possession of same implies criminality on the part of the individual being searched or any other; or potentially compromises the safety of that individual or another.</p> <p>A seizure occurs when - alcohol, and/or; tobacco product, and/or; cigarette papers are surrendered, or are removed from an individual by a Police Officer, for the purpose of safeguarding the health and well-being of that individual or any other, in circumstances where the stop and search tactic has NOT been utilised and no physical search of an individual has taken place.</p>

Prevention and Intervention Activity	<p>Police investigated 26 reports of missing persons in Nairn during this reporting period.</p> <p>South Highland Area Command has a Police Liaison Officer who maintains contact and liaison with residential units where 'Looked after Children' are cared for in the area. This role has resulted in positive working relations between Police and residential unit staff. When required, the Police Liaison Officer works in conjunction with the Missing Person Co-ordinator who similarly enjoys a positive working relationship with residential units.</p>					

PRIORITY – Terrorism and Public Order

Intention – Prevent, Pursue, Protect and Prepare through collaborative preparedness

Objective – Strengthen PREVENT work with Partners and institutions; with Partners, support individuals who are vulnerable to terrorism and violent extremism; strengthen PREVENT work in relation to the internet and Social Media; Effective Multi-agency planning in respect of Counter Terrorism is taking place; Develop our ability to response effectively to any terrorist attack (with a specific focus on emerging high-risk threats, and specialist capabilities).

<p>Counter Terrorism & Domestic Extremism</p>	<p>Workshop to Raise Awareness of Prevent (WRAP).</p> <p>WRAP is an interactive facilitated workshop aimed at front line staff such as police, social services, probation, education and health staff. It seeks to support staff to recognise that using their existing expertise and professional judgement, they may be able to recognise potentially vulnerable individuals.</p> <p>Work is ongoing to develop contacts in the South Highland Area Command in order to run workshops for relevant staff.</p>
