<p>Serious & Organised Crime</p>	<p>Divisional Operation - Intelligence development and investigation into drug supply and use in educational establishments throughout the N Division area, including Skye & Raasay. All intelligence continues to be monitored daily and passed to the Area Inspector for a proactive approach.</p> <p>Divisional Operation – Ongoing investigation into recent online/electronic frauds which have targeted local business/charities and have resulted in the loss of substantial amounts of money in the Division and in the Skye & Raasay Area over the current reporting year.</p>

Prevention and Intervention Activity.	<p>The COVID-19 lockdown in Skye and Raasay’s communities brought out and continues to bring out the best in the majority of the population. Communities have provided support to vulnerable residents and have all collectively looked out for neighbours. However, it was and remains important to highlight that less scrupulous individuals’ may seek to exploit people’s vulnerabilities.</p> <p>National and local online messaging encouraged people to think about their personal safety and encouraged individuals to be vigilant about who they engage with and accept assistance from.</p>
