## **PRIORITY – Road Safety and Road Crime**

Intention - Collaborate to reduce casualties and crime on our roads.

Objective – Whilst working with Partners, deliver a Road Safety Strategy which focuses on: Challenging Driver Behaviour; Education at the road side and elsewhere; Detection of offences linked to contributing factors of Fatal and Serious Road Collisions; and collectively reducing potential harm.

Operation CEDAR involves proactive multi-agency enforcement operations on the roads, which sits alongside education activity and is aimed at improving the behaviour of drivers of all ages behind the wheel. Partner agencies continue to work together to gain a greater understanding of the factors which could |                |                |                  |   |

be used to improve the safety of everyone on the roads and together respond to these issues.

#### **OFFICIAL**

<u>Driver Engagement North</u> - A multi-agency initiative makes use of an interactive driving simulator designed to assess and highlight a participant's reactions, hazard awareness and any potential vulnerabilities on the roads. The project, launched in Inverness during October 2019, received funding from Transport Scotland and is led by Police Scotland, with support from a number of partners including the NHS Highland, Local Authority Community Safety Groups, IAM Roadsmart, Age Concern and RoSPA. The simulator has been specially designed to assess and demonstrate a driver's reactions and abilities in a safe environment under the supervision of specialists who will be able to offer support and advice. While this initiative is aimed at older drivers, we will also be able to offer advice to family members or friends who are concerned about whether someone they know is fit to drive. This initiative is not currently running due to the COVID-19 pandemic.

<u>Festive Safety Campaign 2020</u> – The campaign ran between 01 December 2020 and 02 January 2021. Police Scotland is committed to achieving the Scottish Government's 2020 casualty reduction targets. Increasing awareness of the risks associated with drink/drug driving supports the Force's efforts to reduce road casualties. The campaign was conducted through a combination of intelligence-led high visibility patrols and static road checks.

<u>North Coast 500 (NC500) and Visitor Management</u> - There are Road Policing plans in place for motorcyclists/vulnerable road users and Visitor Management for the year ahead and analytical work has been carried out to ensure Police Scotland are targeting the right areas and road users at the right time.

Police Scotland are committed to reducing road casualties across the Highland area and patrols will be conducted on priority routes on a daily basis and undertaking specific weekends of action on the NC500 route utilising car and motorcycle patrols with the aim to influence driver and road user behaviour, detect and deter criminality on our roads and reassure communities. We will continue to promote our activity through media channels and encourage anyone with road safety concerns to contact Police Scotland.

## **PRIORITY – Serious & Organised Crime**

Intention – Reduce the harm caused by serious organised crime including cyber related crime.

Objective – With Partners work to safeguard the Highland area by taking all opportunities to prevent crime and make the Highland area a hostile environment for Serious & Organised Crime Groups; to improve outcomes for individuals and communities and reduce offending through prevention, early intervention and diversion; in support of our Partners in the Local Authority and NHS via the Highland Alcohol and Drug Partnership Strategy we will direct those who are substance dependant towards recovery through prevention, treatment and support services; with Partners work to reduce the instances of substance misuse in our communities.

**Positive Stop Search** - A positive stop and search is when an item is recovered where possession of same implies criminality on the part of the individual being searched or any other; or potentially compromises the safety of that individual or another.

A **seizure** occurs when - alcohol, and/or; tobacco product, and/or; cigarette papers are surrendered, or are removed from an individual by a Police Officer, for the purpose of safeguarding the health and well-being of that individual or any other, in circumstances where the stop and search tactic has NOT been utilised and no physical search of an individual has taken place.

Intention – Support people considered vulnerable through working with partners.

Objective – With Partners and as corporate parents we will deliver the Highland CHAMPS (Highland Champion Board) strategy; with Partners we will focus on safeguarding communities; with Partners we will address emerging issues through Prevention and Intervention.

# PRIORITY - Terrorism and Public Order

#### **OFFICIAL**

Intention - Prevent, Pursue, Protect and Prepare through collaborative preparedness.

Objective – Strengthen PREVENT work with Partners and institutions; with Partners, support individuals who are vulnerable to terrorism and violent extremism; strengthen PREVENT work in relation to the internet and Social Media; Effective Multi-agency planning in respect of Counter Terrorism is taking place; Develop our ability to response effectively to any terrorist attack (with a specific focus on emerging high-risk threats, and specialist capabilities).

Counter Terrorism & Domestic Extremism.

Workshop to Raise Awareness of Prevent (WRAP).

WRAP is an interactive facilitated workshop aimed at front line staff such as police, social services, probation, education and health staff. It seeks to support staff to recognise that using their existing expertise and professional judgement, they may be able to recognise potentially vulnerable individuals.

Work is ongoing to develop contacts in the North Highland Area Command in order to run workshops for relevant staff.
