#### 1. Purpose/Executive Summary

- 1.1 This report is to inform Members of the progress in monitoring and delivering the Highland Council's third iteration of its Gaelic Language Plan (GLP).
- 1.2 This is the final monitoring report for the current GLP, as the refreshed GLP was approved by Bord na Gaidhlig (BnaG) earlier this month. Therefore this provides an opportunity to revisit the monitoring process and procedure for the forthcoming Plan.
- 1.3 PRMS data is shown in **Appendix 1**, which includes the full report, and **Appendix 2** is a summarised infographic.
- 1.4 The results of the online survey of Gaelic Committee Members' views on the effectiveness of the Gaelic Committee are also presented within this report. The survey questions are available in **Appendix 3** and the results are presented in **Appendix 4**.

#### 2. Recommendations

- 2.1 Members are asked to:
  - i. Discuss, and note the report.
  - ii. Note that the next PRMS report available will be a transitionary report between the current GLP and the refreshed GLP.

#### 3. Implications

3.1 Resource

The delivery of the GLP is funded by The Highland Council, Scottish Government grants and various Bord na Gàidhlig (BnaG) funding streams.

3.2 Legal

The Highland Council is required to have an approved Gaelic Language Plan within the duties of Gaelic Language (Scotland) Act 2005. There are obligations in ensuring that the GLP commitments are implemented.

- 3.3 Community (Equality, Poverty, Rural and Island) The outcomes of the GLP have a strong community focus across the Highlands.
- 3.4 Climate Change / Carbon Clever The Gaelic Team continue to maximise the use of technologies in relation to meetings, travel, online tuition, and other online Gaelic cultural events.
- 3.5 Risk Outcomes with the GLP are not achieved.
- 3.6 Gaelic

Very positive implications regarding the preservation and development of Gaelic language and culture across corporate, education and community sectors. This also enhances the social and economic value of Gaelic and its associated culture.

## 4. Progress against the third edition of the Highland Council GLP

4.1 There are 126 enabling actions in the Highland Council's third iteration of its GLP, which span six themes.

Most of the actions are subject to and supported by the following:

- available resources
- Scottish Government
- support from Bòrd na Gàidhlig
- positive key stakeholder engagement and partnership working
- engagement and collaboration with schools and community groups

### 5. Transition to the refreshed GLP

- 5.1 The Highland Council was informed by Bòrd na Gàidhlig on the 7 May 2024 that they had approved the GLP 2024–29.
- 5.2 The transition process between the two versions of the GLP is currently underway. Many of the enabling actions within GLP 2018–23 are ongoing between iterations of the GLPs and constitute much of the day-to-day work of the Gaelic Team. All of the stated actions within the GLP, including new and enhanced outcomes, are currently being transferred into PRMS.
- 5.3 Reporting against GLP 2024–29 will commence in July 2024. Therefore, a transitionary monitoring report will be provided at the next meeting of the Gaelic Committee in September. It is hoped that the first full monitoring report will be available in November 2024.

### 6. Gaelic Committee Member Survey 2024

6.1 An online survey of Gaelic Committee Members' views on the effectiveness of the Gaelic Committee was circulated between January and April 2024 with six responses collected. The focus was on securing Members' views on a range of topics connected to the effectiveness of the Committee including the use of Gaelic within the Gaelic Committee, its effectiveness in delivering its core functions and training and development needs. The survey questions can be found in **Appendix 3** and the results are summarised in **Appendix 4**.











## Appendix 4 - Gaelic Committee Member Survey 2024

#### Introduction

An online survey of Gaelic Committee Members' views on the effectiveness of the Gaelic Committee was circulated between January and April 2024 with six responses collected. The focus was on securing Members' views on a range of topics connected to the effectiveness of the Committee including the use of Gaelic within the Gaelic Committee, its effectiveness in delivering its core functions and training and development needs. The survey questions can be found in appendix 2.

#### Key findings

Key findings are:

<u>Gaelic visibility in the Gaelic Committee</u> Members agreed that:

- There is sufficient written Gaelic at the Committee,
- There is sufficient spoken Gaelic at the Committee, and
- Simultaneous translation of Gaelic to English should be available during the Committee.

Comments received indicate the Members feel that simultaneous translation from Gaelic to English would be a positive improvement to the Gaelic Committee meetings.

#### The Members' roles within the Gaelic Committee

Members agreed that:

- They understand the role expected of them in the Committee and
- That they actively engage in questioning during the Committee.

Members neither agreed nor disagreed that:

- They had received sufficient training and support for in their role on the Committee and
- Gaelic Awareness training would assist them in their role on the Committee.

Comments received indicate that Members feel the Highland Council's work with the Scottish Government and the monitoring of legislation could be more prominent within the Committee meetings.

#### The Effectiveness of the Gaelic Committee

Members agreed that the Committee is effective in the following functions:

- Monitoring, scrutinising and promoting the implementation of the Highland Council's Gaelic Language Plan, including the delivery of Gaelic education.

- Working with Gaelic development agencies in promoting, developing and sustaining the Gaelic language, culture and heritage in the Highlands and
- Monitoring the implications of legislation in respect of the Gaelic language and advising the Council of its impacts across the Highlands.

- There is sufficient cross-service collaboration to support the implementation of the Gaelic Language Plan and
- The Committee Members have the appropriate skills and expertise to fulfil their roles effectively.

### Gaelic Skills

The level of confidence in Gaelic skills varied across Members.

Comments received indicate that Members would like access to Gaelic training and/or Gaelic classes.

#### Analysis and Areas for Improvement

The main areas for improvement identified through the survey are the use of spoken Gaelic and simultaneous translation during the committee meetings, cross-service collaboration, training in Gaelic skills, and the role of the Members in the Committee.

#### **Proposals for Improvement**

A suite of Gaelic awareness and Gaelic in the Workplace courses are currently under development. It is intended that a training session will initially be delivered face-to-face to elected Members and will then be supplemented by an online training resource.

Work is currently underway to determine the best method for providing simultaneous translation during the Committee meetings. Bord na Gàidhlig funding was recently secured for the Highland Council's "Conaltradh is Corporra" project which will be used to enhance our digital communications. The implementation of simultaneous translation during Gaelic Committee meetings is listed as an outcome of this project.

A cross-service GLP implementation group will be established.
