Purpose/Executive Summary

This report provides an update on progress of all cases within the 'Major' and 'National' development categories currently with the Planning and Development Service for determination. The report also details progress on proposals submitted under S36 or S37 of the Electricity Act 1989 on which the Council is consulted.

Recommendation

Members are asked to note the current position of these applications.

1. Update on Progress

- 1.1 Appendix 1 and 2 contains a list of all applications for Major Development currently with the Service and awaiting determination. A brief update on the progress of these applications is provided, including a likely timescale for each case to be determined.
- 1.2 Appendix 3 provides a list of all significant Electricity Act applications. For many of these the Council has already provided its response to Scottish Government. Only once Scottish Ministers determine these cases will they be removed from the list. In terms of performance reporting, for these type of applications the Council is not required to meet the same target timescales as expected with planning applications.
- 1.3 Appendix 4 provides a list of all major scale planning permissions and Electricity Act consents issued within the last two years to provide members with an update on the status of these developments.
- 1.4 Details for any of these applications can be obtained through the Council's eplanning portal <http://wam.highland.gov.uk/wam> by entering the respective case reference number. The following abbreviations have been used in the appendices:
 - PCO – Pending Consideration
 - PDE – Pending Decision

2. Delegated Refusals of Major Applications and Current Appeals / Judicial Reviews Related to Major Applications

- 2.1 Since the Major Developments Update Report presented to the last committee, the following major application has been refused using delegated powers:
 - None
- 2.2 Progress with applications where the Council has raised objection:
 - 22/04580/S37 - Skye Reinforcement Project - Construct and operate approximately 110 kilometres (km) of new double circuit steel structure 132 kV overhead transmission line and associated infrastructure. Following joint meetings of North and South Planning Applications Committees on 22 March 2023 and 08 November 2023, contrary to Planning Officer's recommendation, the Council raised an objection to the application. We now await details of any further procedure from the Scottish Government's Energy Consents Unit, ahead of Scottish Government's decision on the application.

- 22/02717/S36 - Strath Oykel Wind Farm and battery storage, 11 wind turbines of up to 200 metres and associated infrastructure. The application was reported to committee in October 2022 and January 2023 where, contrary to the Planning Officer's recommendation, members raised an objection. A public local inquiry took place in October 2023 covering matters including policy, landscape and visual impact. We now await the decision of Scottish Ministers.
- 21/05591/S36 - Hollandmey Energy Development - Erection and Operation of Renewable Energy Development in perpetuity comprising 10 wind turbines with a ground to blade tip height of 149.9m, ground mounted solar arrays, battery energy storage system, access tracks, permanent met mast and LiDAR, two temporary met masts, up borrow pits and associated infrastructure. The Planning Officers' report on handling was circulated to members in November 2022 and subsequently, the Council raised an objection. A hearing session took place in October 2023 covering matters including policy, landscape and visual impact. We now await the decision of Scottish Ministers.
- 21/01921/S36 - Garvary Wind Farm - Erection and operation of wind farm for a period of 30 years, comprising of 25 (as amended) wind turbines with maximum blade tip height of up to 180m, access tracks, up to 6 borrow pits, substation, battery storage compound, control building, 4 meteorological masts, and ancillary infrastructure. The application was reported to committee in February 2021 and June 2023 where, in line with the Planning Officer's recommendation, members raised an objection. A public inquiry is due to be held in March 2024 covering matter including policy, landscape and visual. Thereafter, a decision will be made by Scottish Ministers.
- 22/05533/S36 - Kirkton Energy Park - Erection and operation of a wind farm comprising of 11 wind turbines of up to 149.9m blade tip height, battery energy storage system, access tracks, substation, control building, 2 borrow pits, temporary construction compound and associated development for a period of 30 years. The application was reported to committee in January 2024 where, in line with the Planning Officer's recommendation, members raised an objection. The Council awaits details of further mandatory public local inquiry procedures ahead of Scottish Minister's decision on the application.
- 23/02320/S36 - Melvich Wind Energy Hub - Erection and operation of a wind farm for a period of 40 years, comprising 12 wind turbines with a maximum blade tip height of 149.9m, energy storage facility, access tracks, borrow pits, substation, and ancillary infrastructure. The application was reported to committee in December 2023 where, in line with the Planning Officer's recommendation, members raised an objection. The Council awaits details of further procedure ahead of Scottish Minister's decision on the application.
- 22/01972/S36 - Armadale Wind Farm - Erection and operation of wind farm for a period of 30 years, comprising of 9 Wind Turbines with maximum blade tip height of 149.9m, access tracks, borrow pits, substation, control building, met mast, battery energy storage system and ancillary infrastructure. The application was reported to committee in March 2024 raised an objection. The Council was informed of Scottish Ministers intention to hold a public inquiry, however the applicant subsequently decided to **withdraw** the application on 8 May 2024.

2.3 For those cases under the Electricity Act where no objection was raised, and we are awaiting the decision of the Scottish Ministers, or we are awaiting the instruction on next steps following an objection being raised to an application, those cases will be listed in the appendix to this report. A notable recent update is in relation to the following application:

- 23/02936/S36 - Creag Riabhach Extension Wind Farm - erection and operation of 3 turbines with a maximum blade tip height of 149.9m, installation of Battery Energy Storage System, access tracks, and associated infrastructure. Application reported to committee in March 2024 where members decided to raise no objection subject to 1 turbine deletion. **Confirmation received from the Energy Consents Unit that the applicant has agreed to the deletion of turbine T1 as per the Council's consultation response.** Awaiting any further procedure ahead of determination by Scottish Ministers.

2.4 Progress with applications which are at appeal / have been called in for Scottish Minister's determination:

- 23/00580/FUL - Coul Links Golf Course - Construction of an 18 hole golf course, practice area, access, parking, ancillary infrastructure and the change of use of existing buildings to form clubhouse, pro shop, maintenance shed and ancillary facilities. The application was reported to committee in December 2023 where, contrary to Planning Officer's recommendation, members were minded to grant planning permission. Due to the unresolved NatureScot objection, the decision on the application has been called in by Scottish Ministers. The Council awaits details of further PLI procedures ahead of Scottish Minister's decision on the application. It is anticipated that the PLI will take place in November 2024.
- 22/05178/FUL – Fearn AD Plant - Erection and operation of an anaerobic digestion plant and ancillary infrastructure. The application was refused under delegated powers in October 2023. An appeal has since been lodged and the appointed reporter has requested an Environmental Impact Assessment to be provided by the applicant.

2.5 The Planning Authority are not currently subject to any applications to the Court of Session for Judicial Review of decisions on major / national application.

Recent Decisions by Scottish Ministers

3.1 There have not been any decisions on any other major / national scale developments have been issued by the Directorate for Planning and Environmental Appeals in the North Planning Applications Committee area since those reported to the last committee.
