Name of consultation: Review of the proposal to establish Gaelic Medium catchment areas

Your comments: I have read the comments that have been added from the consulation regarding my case that was put forward. I find it very disappointing that our particular case is not being positively looked on but the case put forward by Ardersier is. The area we stay is on the edge of the croy/cawdor border, historically children from this area have all attended Cawdor Primary School. Our address to Millbank Primary school is 6.6 miles, our address to Bun-Sgoil Ghàidhlig Inbhir Nis is 12.7 miles. The response we got was

'The proposed GM catchments are based on the existing EM catchments, and the address concerned lies with the Croy PS catchment area, albeit close to the boundary. Although GM catchment areas overlap a number of EM catchments. it is logical to group the EM catchments for GM purposes and to keep the EM catchments as whole entities. The Council does not favour varying the detailed boundaries of each catchment, to introduce differences between EM and GM education boundaries.'

'To further inform its decision on the above responses, Highland Council undertook an online survey of parents of primary and pre-school children, who were interested in GME. There were 3 responses from parents in Ardersier, all of whom favoured being part of the Millbank PS/Nairn Academy catchment for the purposes of GME. One response from Croy suggested that community should remain within the BSGI/IRA catchments for the purposes of GME.';

It seems very unfair that one response from the Croy area asking to stay in the BSGI/IRA catchment is taken on more merit than my request for my child to be put into the Nairn catchment area. Please could you let me know why one family has priority over another family in the same catchment area? If there are only myself and one other family in the 'Croy' area that responded why are they being given priority on their views of the current boundaries?

It seems very unfair that other families are being given priority and help with sending their children to Gaelic education in the local area but we are not also being given that same opportunity. I would have to send my daughter twice the distance to school to access Gaelic education should I want free transport but other children in Ardersier who will be travelling the same distance around 6 miles will get free transport and not have the financial burden of transportation costs. It also seems unfair that children who have chosen to attend the Bun-Sgoil Ghàidhlig Inbhir Nis and will be outwith the catchment area when these are defined will continue to get free transport to school from outwith the catchment area.

I would like you to reconsider our unique case for having out address in the catchment area for Nairn due to us being on the border between Cawdor and Croy and the fact that historically this area went to Cawdor Primary School. Also I would like you to consider that you are putting my family potentially in the situation of having to leave Gaelic Education if we can't afford to drive our child to school but others will be transported from Ardersier(the same distance to Millbank) for free. Yes we would have the option to send her for free to Bun-Sgoil Ghàidhlig Inbhir Nis but the increased travel time and leaving her current friends and relationships that have been built would be very difficult for her and most likely result her in leaving Gaelic education completely.

Name of consultation: Review of the proposal to establish Gaelic Medium catchment areas

Your comments: The Statutory Guidance on Gaelic Education recommends that catchment areas be established for schools where Gaelic-medium education (GME) is provided (Section 2.53 & 2.54).

Therefore, Bòrd na Gàidhlig welcomes the proposals following the consultation with stakeholders and agree with the recommendations that catchment areas be established for Gaelic Medium Education in the listed schools in this proposal, and in line with the recommendations from Foghlam Alba.
