Report Title: Bereavement Services – Project Updates

Report By: Assistant Chief Executive - Place

1. Purpose/Executive Summary

1.1 This report provides Members with an update on the Council's Bereavement services capital projects to maintain burial ground capacity and crematorium services for the Highlands.

2. Recommendations

- 2.1 Members are asked to:-
 - NOTE the progress of current projects on burial ground extensions and Inverness Crematorium refurbishment; and
 - ii. **NOTE** future burial ground extension projects in Highland.

3. Implications

- 3.1 **Resource** The Council on 14 September 2023 approved a capital budget for bereavement services, with budget of £2.931m for identified projects in 2024/25 and £3.068m for 2025/26 2028/29.
- 3.2 **Legal** The Council has a statutory obligation to manage burial provision, memorial safety and cremations as set out in the Burial and Cremation (Scotland) Act 2016.
- 3.3 **Risk** If burial ground extensions or new sites are not provided there is a risk that the Council will be unable to provide burials in some locations to meet the expectations and preferences of communities. The establishment of a project board for proactive oversight and support for projects serves to reduce service risks.
- 3.4 Health and Safety (risks arising from changes to plant, equipment, process, or people) The safety of staff and visitors in burial grounds is a statutory obligation for local authorities and memorial safety inspections are undertaken to reduce risks.
- 3.5 **Gaelic** There are not considered to be any Gaelic implications.

4. Impacts

- 4.1 In Highland, all policies, strategies or service changes are subject to an integrated screening for impact for Equalities, Poverty and Human Rights, Children's Rights and Wellbeing, Climate Change, Islands and Mainland Rural Communities, and Data Protection. Where identified as required, a full impact assessment will be undertaken.
- 4.2 Considering impacts is a core part of the decision-making process and needs to inform the decision-making process. When taking any decision, Members must give due regard to the findings of any assessment.
- 4.3 This is a monitoring report and therefore an impact assessment is not required.

5. Background

- 5.1 Section 3 of the Burial and Cremation (Scotland) Act 2016 requires each local authority to provide at least one burial ground within its area. The Highland Council has 245 burial grounds. The Highland Council also operates Inverness Crematorium, located at Kilvean, Inverness.
- 5.2 The table below details the number of cremations and burials undertaken in the last few years:-

6. Burial Ground Capacity Projects

- 6.1 Through the capital programme the Council aims to provide appropriate burial ground provision in the Highlands. The team are reviewing burial ground extensions where current capacity is less than 10 years based on past trends. Information on burials and lair sales is monitored on a weekly basis following submission from all bereavement services administrative teams.
- 6.2 As Members are aware, a project board is in place to support the work of the team delivering burial ground extensions and new sites. The board ensures good governance in delivering the programme and the remit has been expanded to include all bereavement services capital projects including:-
 - projects to develop burial ground extensions and new burial ground sites;
 - projects to maintain, develop and improve Inverness Crematorium;
 - projects to maintain existing burial grounds including works related to the memorial safety programme; and

- projects to support communities to maintain existing war memorials.
- 6.3 The Board recognises the challenges in some areas with burial ground provision with it becoming increasingly difficult to identify available land for development of extensions or for new burial grounds. The reasons include:
 - a) land availability and purchase cost;
 - b) developments costs;
 - c) land suitability and geology land conditions and requirements must comply with SEPA guidelines for burial grounds, be relatively flat land with little or no rock formations:
 - regulatory requirements the selection of any new sites or extensions must not cause any pollution to the environment, including groundwater and this is regulated by SEPA; and
 - e) acceptability with local Planning considerations.
- 6.4 Progress on the current approved projects is summarised in **Appendix 1**.
- 6.5 As can be seen, all projects are on track with a green RAG status apart from Glen Nevis, Lochaber. The Glen Nevis burial ground in Fort William is estimated to reach full capacity by the end of 2025. Significant work has been done locally with over 40 sites considered but unfortunately, ground conditions are very challenging in the area. Work is being progressed at a site adjacent to the current cemetery to improve ground conditions. A planning application has been submitted for Phase 1 of the works to allow for significant drainage works to take place.
- 6.6 At Kilvean burial ground in Inverness, drainage works have been completed for the next extension. When complete this area will provide 1600 lairs, approximately another 10 years capacity. The PDU team are designing further improvements to the drainage at Kilvean which will allow a number of unused areas within the existing site to be utilised for future lairs. Long term planning for the Inverness area will require a new burial ground and initial land investigations are underway to identify a suitable site for this development.
- 6.7 In addition to the projects in **Appendix 1**, the team are progressing investigations and works at the following locations:-

- 6.8 The following projects have been recently completed:-
 - Works to extend Canisbay Cemetery, Wick have now been completed. The
 extension will allow for 500 additional lairs / 80+ additional years capacity in the
 area.
 - Design works for additional lairs within the existing Duror Cemetery, Appin have now been completed and works are expected to be complete before the end of the year. Works will allow for an additional 140 lairs / 20+ years capacity.
 - Drainage improvement works at Rosskeen Burial Ground have been completed to address surface water issues that occurred last winter.
- 6.9 Work is ongoing to review detailed projects for the capital budget for 2025/26 2028/29 of £3.068m. As shown in **Appendix 2**, current data indicates 22 additional burial grounds that will require capital expenditure to provide extensions or new sites. The bereavement services team will continue to engage with local members on projects in their area.

7. Inverness Crematorium

- 7.1 Inverness Crematorium provides a full cremation service for the Highlands, with 1387 cremations conducted in 2023. The crematorium is inspected annually by Scottish Government inspectors and every 5 years by the Federation of Burial and Cremation Authorities.
- 7.2 As Members are aware, a project group is taking forward the cremator replacement project which includes installation of two new gas-fired bariatric cremators with associated abatement plant. The UK government has indicated that updated plant will be required by 2027 to meet tighter emission standards for crematorium. The Council on 14 September 2023 approved a capital budget for the Crematorium project of £1.2m with £50k allocated for 2024/25 and £1.15m for 25/26.
- 7.3 The tender process for the cremators and abatement plant supplier has been completed and the contract has been awarded to Facultatieve Technologies Ltd (FT). FT is Europe's largest supplier of specialist cremation equipment and have been carrying out cremator installations for over 40 years. FT has installed cremators and abatement systems throughout the world including over 150 sites within the UK to date. The company have an experienced maintenance team covering the whole of the UK. Support is provided both remotely via a broadband link-up with the office-based support team and also via their extensive mobile maintenance team. FT has the largest installation and maintenance team available to cover the UK.
- 7.4 The contract award to FT covers the design, supply and installation of the two cremators and abatement plant. The Project team note that the capital costs of the project including the FT contract, the construction costs of the new extension, professional fees, and contingency, is currently estimated at £1,651,170.20, which is £451,170.20 over the approved capital budget of £1,200,000. This additional estimated costs can be accommodated within the approved capital budget for bereavement services of £3.068m for 2025/26 2028/29. The Bereavement Services Capital Project Board will continue to monitor the extension programme ahead of future reviews of the Council's Capital Programme.

- 7.5 The contract award with FT also covers a 20-year maintenance and service contract which will be funded through the Bereavement Services revenue budget as with the existing maintenance and service arrangements.
- 7.6 The aim is for works at Inverness crematorium to be undertaken in 2025 with phasing of the works to minimise any impact on the provision of cremations and services during the refurbishment works.
- 7.7 As Members are aware, a specialist consultant has also been appointed to prepare a detailed feasibility report for the possibility of a crematorium in the Lochaber area. This report has been delayed due to the Inverness Cremator replacement project and will be reported to the Committee early in 2025.
