Purpose/Executive Summary

This report provides an update on progress of all cases within the 'Major' and 'National' development categories currently with the Planning and Development Service for determination. The report also details progress on proposals submitted under Section 36 or Section 37 of the Electricity Act 1989 on which the Council is consulted.

Recommendation

Members are asked to note the current position of these applications.

1. Update on Progress

- 1.1 Appendix 1 contains a list of all applications for Major Development or National Development currently with the Service and awaiting determination. A brief update on the progress of these applications is provided, including a likely timescale for each case to be determined.
- 1.2 Appendix 2 provides a list of all significant Electricity Act applications. It should be noted that for many of these, the Council has already provided its response to Scottish Government. Only once Scottish Ministers determine these cases will they be removed from the list. From a performance point of view, the Council is not required to meet the same target timescales expected with planning applications.
- 1.3 Appendix 3 provides a list of all major scale planning permissions and Electricity Act consents issued within the last two years to provide members with an update on the status of these developments.
- 1.4 Details for any of these applications can be obtained through the Council's eplanning portal <u>http://wam.highland.gov.uk/wam</u> by entering the respective case reference number provided. The following abbreviations have been used in the appendices:
 - PCO Pending Consideration
 - PDE Pending Decision
 - S36RO –raised an objection to an application for energy generation under the Electricity Act
 - S36RNO raised no objection to an application for energy generation under the Electricity Act
 - S37RO raised an objection to an application for energy transmission under the Electricity Act
 - S37RNO raised no objection to an application for energy transmission under the Electricity Act

2. Delegated Refusals of Major Applications and Current Appeals

- 2.1 Since the Major Developments Update Report presented to the last South Planning Applications Committee, no major application has been refused using delegated powers.
- 2.2 Progress with applications where the Council has raised objection:
 - 22/04580/S37 Skye Reinforcement Project Construct and operate approximately 110 kilometres (km) of new double circuit steel structure 132 kV overhead transmission line and associated infrastructure. Following joint meetings of North and South Planning Applications Committees on 22 March 2023 and 08 November 2023, contrary to Planning Officer's recommendation, the Council raised an objection to the application. We now await details of any further procedure from the Scottish Government's Energy Consents Unit, ahead of Scottish Government's decision on the

application.

- 23/05579/S36 Culachy Wind Farm Erection and operation of a wind farm for a period of 35 years, comprising 8 wind turbines with a maximum blade tip height of 200m, access tracks, underground cabling, substation, maintenance building, batching plant, borrow pits and ancillary infrastructure. Application reported to committee in October 2024 where members agreed to raise an objection as per officer recommendation.
- 23/02462/S36 Loch Liath Wind Farm Erection and operation of a wind farm for a period of 35 years, comprising a total of 13 wind turbines with Turbines 2, 3, 4, 5, 8, 9, 10, 11, 12, and 13 having a maximum blade tip height of 200m, and Turbines 1, 6 and 7 having a maximum blade tip height of 180m, access tracks, borrow pit, substation, control building, anemometer mast, and ancillary infrastructure. This case will be determined by the Energy Consents Unit. Application reported to committee in February 2025 where members agreed to raise an objection as per officer recommendation. A PLI is anticipated to take place in late 2025.
- 2.3 For those cases under the Electricity Act 1989 where a Public Local Inquiry has been held and we are awaiting the decision of the Scottish Ministers the case will be listed in the Appendix to this report only.

3. Recent Decisions by Scottish Ministers and Judicial Reviews

- 3.1 Since the report to the last committee no decisions have been issued by Scottish Ministers in relation to applications made under the Town and Country Planning Act and the Electricity Act in the South Planning Applications Committee area.
- 3.2 Following Scottish Minister's 23 February 2024 refusal of Lethen Wind Farm Erection and operation of a Wind Farm for a period of 35 years, comprising of 17 Wind Turbines with a maximum blade tip height 185m, access tracks, borrow pits, substation, energy storage facility, control building, meteorological mast and ancillary infrastructure (THC ref 21/05946/S36), on 21 May 2024 the applicant (Fred Olsen Renewables) subsequently applied to the Court of Session for judicial review of this decision. In summary, the applicant's grounds for review rest upon the assertion that Scottish Ministers erred in law procedurally in the way they reported on and determined the application, with Scottish Ministers in this case exercising their discretion not to hold a Public Local Inquiry following the Council's late objection, and instead proceeding with the refusal of the application. The case will now be handled by the Court of Session and the Council will monitor and report back to SPAC on the outcome in due course.
